
The 2025 Earth Day Subcommittee, created by the EHPC, is providing an update on planning activities for the event.

Recommendation(s)

That the Environmental and Historical Preservation Commission:

1. Reconsider the issue of whether to recommend to the City Council that they approve incorporating the word "Sustainability" in the name of the Commission, as requested by Commission Member McBean, and provide any necessary direction to the Staff Liaison.

SUMMARY

At the March 10, 2025 regular Commission meeting, Commission Member McBean motioned to continue the commission name discussion item to the April 14, 2025 to allow the Commission to research the Sustainability department.

Commission Member McBean purports that it is not necessary to include the word "Sustainability" in the name of the Commission, since she has rationalized that there is an "entire City Division" that is responsible for "sustainability" efforts in the City.

As noted in the March 10, 2025 Staff Report, in order to effectuate a change in the name of the Commission, the Commission will have to submit a recommendation to the City Council which the City Council has discretion to accept or reject. However, should the City Council accept the recommendation, it would have to introduce (first reading) and


adopt (second reading) an ordinance to formally change the name of the Commission since the Commission and its name were adopted by ordinance and codified in the Municipal Code.
