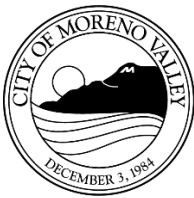

RECOMMENDED ACTION

Staff recommends that the Senior Citizens' Advisory Board (S.C.A.B.) receive and file this program update.

SUMMARY

- Senior Center attendance March 2025: 4,525, averaging 226, (February 2025: 4,545)
- Senior Center membership end of March 2025: 4,665
- Meals delivered in March 2025: 2,800 meals to 400 seniors, averaging 100 seniors per week.
- Hot lunches served March 2025: 2,313 averaging 115 per day. (February 2025: 2,196 averaging 109 per day)
- FSA has continues the take home meals on weekends for seniors.
- Feeding America distributed (265 food boxes of non-perishable food boxes on April 10, 2025, Senior Center continues to lead the I.E., in boxes distributed to seniors. Food distribution has been moved to the Conference and Recreation Center.
- Construction of the Senior Center expansion continues.
- The Center will continue operating as a warming center for seniors when temperatures fall below 40 degrees.
- The Center's banquet room continues to average two banquet rentals a month and two church rentals every Sunday and two classroom rentals weekly.
- Healthcare agencies continue to be on site answering any healthcare questions.
- Friends continue to provide free shuttle service to seniors for all medical and grocery needs as well as free coffee.
- Haircuts continue to be full at the senior center every Tuesday. Appointment required.
- Translation headsets are available for all meetings if needed. Lead time request must be 72 hours.
- CPR classes have resumed, signup sheet available.
